CANCELLATION

Any cancellation made between 120 days before retreat begins and 90 days before retreat begins will result in a loss of 50% of full tuition.

Any cancellation made 90 days before retreat begins will result in a total loss of funds.

We reserve the right to cancel the retreat if it is not meeting the retreat's participant minimum OR because of unforeseen COVID restrictions. If either of these occur, we will see that your deposit and tuition are refunded in full.
